UNDERGRADUATE ADMISSION INFORMATION FOR INTERNATIONAL STUDENTS

GENERAL INFORMATION

Bridgewater State University, enrolling approximately 8,000 full-time undergraduate students, is located 30 miles south of Boston, Massachusetts in the rural/suburban town of Bridgewater, population 26,563. Commuter rail service offers easy access to Boston direct from the on-campus train station.

The university provides the individual attention so important to the academic and cultural adjustment of international students. ESL courses are offered on a limited basis. There are also special classes in reading, writing and study skills available. Approximately 130 international students are enrolled at the university representing more than 29 different countries.

In general, students must depend on their own resources to finance their entire education. Permission to work is difficult to obtain because of immigration regulations and work opportunities are increasingly scarce. Campus employment is available to international students on a limited basis.
